## Contributors Get Valuable Tax Credits

- You earn a **state income tax credit** worth up to 75% of the amount you contribute, which directly reduces your Oklahoma income taxes on a dollar-for-dollar basis.
  - Married couples can earn up to \$2,000 in tax credits annually.**
  - Individual taxpayers can earn up to \$1,000 in tax credits annually.**
- You may also claim a **tax deduction** for your charitable contribution that lowers your taxes even further if you itemize deductions.
